TERMS & CONDITIONS CHRISTMAS CRAFT FAIR



- 1. All stalls must be booked in advance.
- 2. The Organisers reserve the right to refuse applications.
- 3. Space allocations will be determined by the Organisers.
- 4. Any special requirements will be accommodated where possible.
- 5. Details of stall allocation will be given on arrival at the Show.
- 6. Stallholders participate in the show at their own risk.
- 7. The Bat & Ball Country Pub provides public liability insurance but all Stallholders are also recommended to take out their own insurance to cover loss or damage to their own goods and possessions.
- 8. The Bat & Ball cannot be held responsible for injury or accident caused by a Stalholder's product or exhibit, loss of profits, for damage or theft of Stallholders stock or interruption of power or services.
- 9. Stallholders will be held responsible for any loss or damage that they cause to the event site.
- 10.Stallholders are responsible for the removal of all litter, waste, stand materials etc. from their allocated space.
- 11. Failure to comply within the terms and conditions may result in space allocation withdrawal.
- 12.A non-refundable deposit is required by 09/10/2024. Payment link will be sent via email. NO REMINDER WILL BE SENT. Updated invoice will follow after payment of deposit.
- 13.Full payment is required by 09/11/2024.
- 14.Stallholders may park in the field next to the marquee where the event will be held which will be signposted on the day.
- 15.Set up will be from 1pm on Tuesday 3rd and 10am on Wednesday 4th December.
- 16.Any damage caused by the use of tape will be the responsibility of the stallholder
- 17.If a stallholder needs electricity this MUST be requested at the time of paying the full invoice amount. Any banners, rails, signs, small tables/shelves etc that you take MUST fit within the space along with the table and not interfere with other stallholders. For example if you take a rail or additional table/shelving unit etc you must then use a smaller table supplied by yourself so that it all fits within the space allowing for room for others to get in and out. If a stallholder needs additional space, then additional space should be purchased. Stallholders will be shown to their table/space on arrival or it can be found by the label we have put out. This decision is final no complaints or arguments on the day will be accepted. Stallholders who decide to argue with staff regarding placements will be asked to leave the event and will NOT be refunded. The Bat & Ball Country Pub will NOT tolerate abuse of our staff in any manner.
- 18.Stallholders can cancel their appearance at a market up to 4 weeks prior to the event. You will be refunded the total amount MINUS the non-refundable deposit paid.
- 19.If cancellations are made within the 4 week period prior to the event, no money will be refunded unless alternative stallholders can be found.
- 20.'Last minute cancellation spaces' that are booked, are not subject to the 4 week cooling off period. Stallholders attending both days who wish to leave goods overnight, please note marquee is not secure but we will do our upmost to help you store your items inside but at YOUR OWN RISK.
